Treasurers Report

- The computer purchased last financial year is now included in the depreciation calculation.
- The increased use of Eftpos requires future treasurers to transfer funds to the General Account every month since the Eftpos account is linked only to the General Account.
- The Auditor recommends that two members count the proceeds of collection jars at the point of collection.
- In response to a question, Tony confirmed that depreciation is being calculated on a 3 year basis.
- Tony thanked Brian Bartle and Ian Roberts for assisting with the audit and Bob Davison for acting as reserve treasurer during the year.

The Auditor's report found no significant issues.
